Frequently Asked Questions

Q. What is the Employee Giving Campaign?

A. An opportunity for employees to support OMH (a non profit organization), and its charitable mission. All donations to the OMH Employee Giving Campaign are used to buy new equipment, fund education programs like Reach Out and Read and the Diabetes Self Management Program and assist OMH patients. Gifts to the Employee Giving Campaign can be given in the form of cash, or an annual pledge fulfilled through easy biweekly payroll deductions.

Q. Why should I participate in the Employee Giving Campaign?

A. Employee donations enable our staff to utilize the best equipment, facilities and medical technologies when providing quality healthcare. In an era of rising costs and diminishing reimbursements, meeting this commitment is a greater challenge than ever before.

Q. How much of my dollar actually goes to the program or service provided?

A. 100% of your gift to Foundation goes directly to OMH for equipment needs.

Q. How does payroll deduction work? Can I change my pledge at any point in time?

A. Your specified gift amount is taken out of each paycheck during the course of they year. **Every gift counts.** Your gift combined with that of your friends, neighbors and co-workers truly makes a difference in our community. You may change or stop payroll deduction at any time. Please contact the Foundation to make any changes.

Q. Where can I turn in my completed form?

A. Employees may return their forms to the Foundation office at OMH (Suite 5 in the Hazel Shipp Building), to your department manager, or through inter-office mail.

Q. Is my gift tax deductible?

A. Yes. You will receive a detailed annual statement in January of each year.
